## MASZ PRAWO DO OCHRONY PRZYRODY

One of the key issues of concern related to nature conservation is failure of the law enforcement authorities to refer the cases to judicial authorities, followed by issuing light sentences and frequent dismissals.

This exposes the Polish nature to losses caused by committed environmental crimes and offences.

During implementation of the LIFE 15 GIE/PL/000758 project “You have right to effective protection of nature”, we attempted to monitor the sentences issued by the Polish courts in the area of nature protection. This body of case law presents the cases, in which the collected evidence allowed punishing for environmental crimes and offences.

We are aware of the vital role of social awareness in environmental protection and hope that the presented sentences will result in increasing the level of knowledge in the field of legal protection of nature.
